PPE Safety Officer



The PPE Support role has changed

- COVID management wards require an external and internal PPE Safety Officer
- Mixed wards (SCOVID/COVID) no longer require a designated PPE Safety Officer
- A buddy model will be used to ensure safe PPE practices
- PPE Safety Officers will be a mix of Clinical and Non-clinical employees
- PPE Safety Officer role = observe the application and removal of PPE
- PPE Safety officer must meet credentialed education and training before being rostered to the role
- Escalate any issues as per normal process

- · Observe and alert
- Ensure PPE stations are compliant



Our PPE Model has been revised:

- PPE Safety Officers will no longer be required for S/COVID
- Maximum of 2 Safety Officers in unit
- PPE Safety Officer may not be a nurse/midwife
